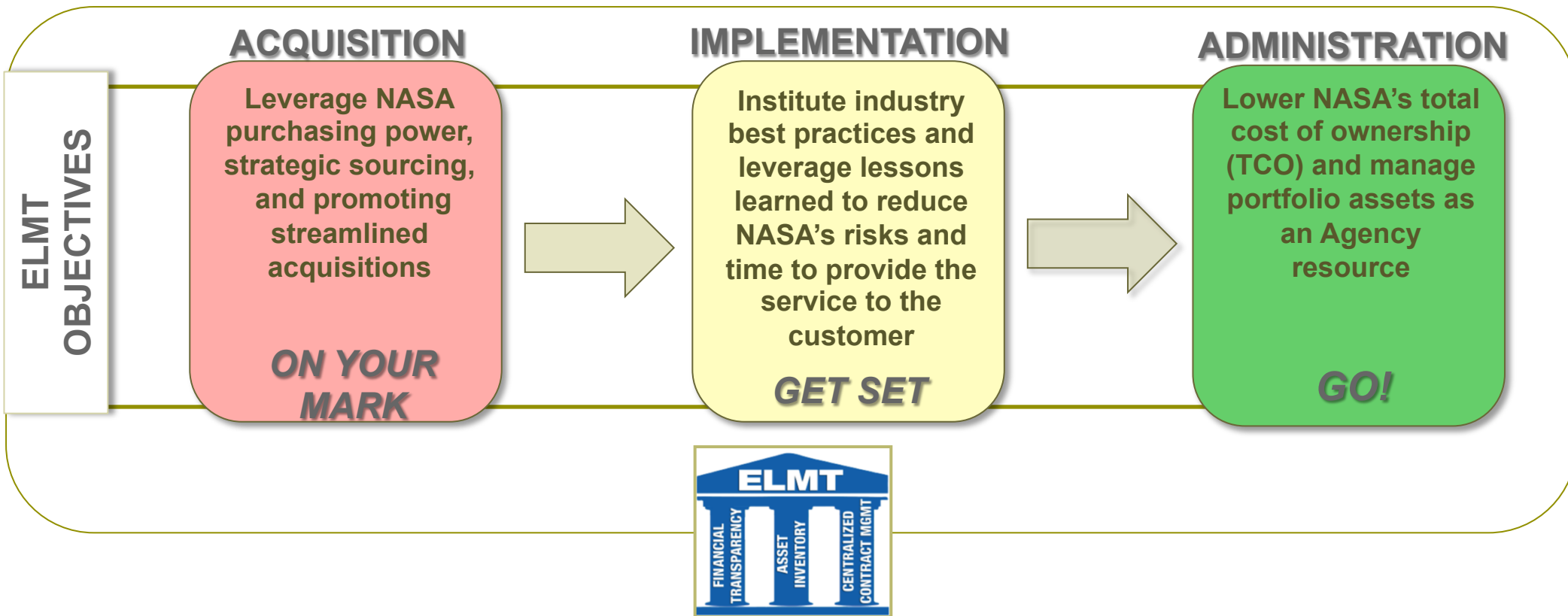

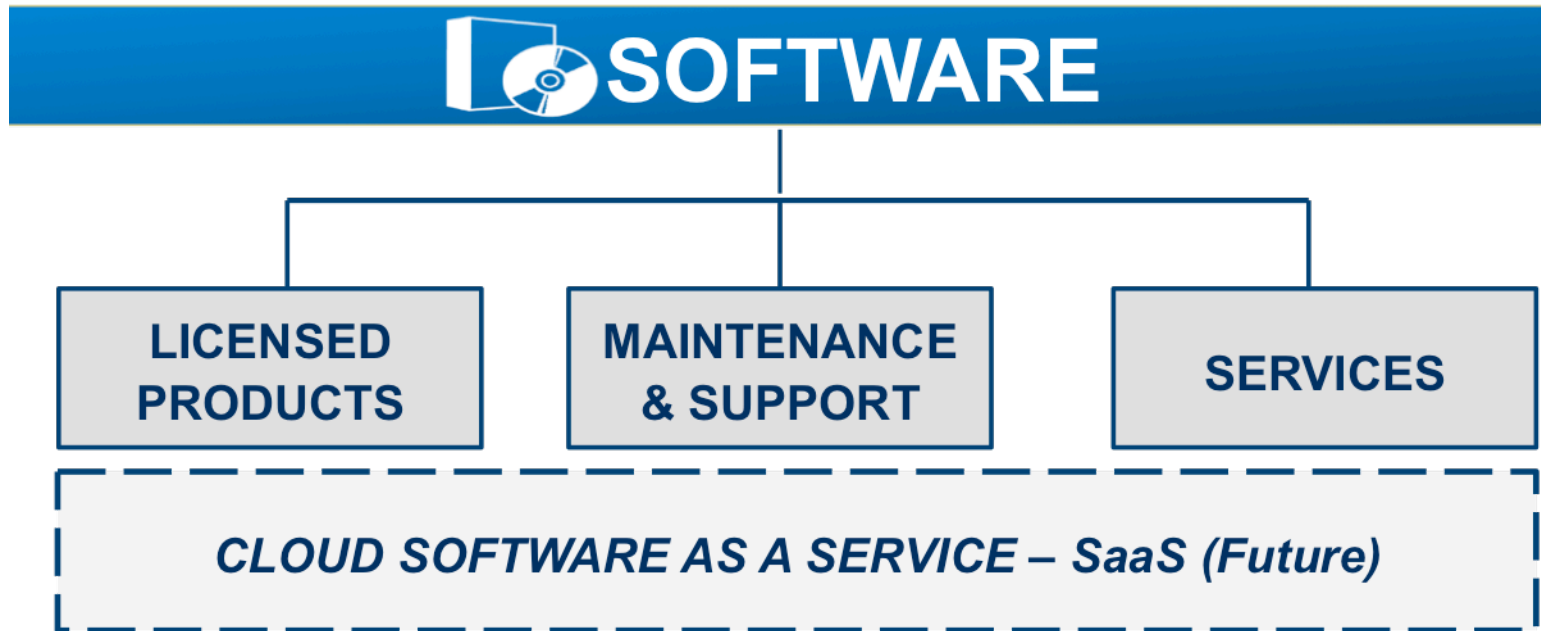

    - » Financial Transparency

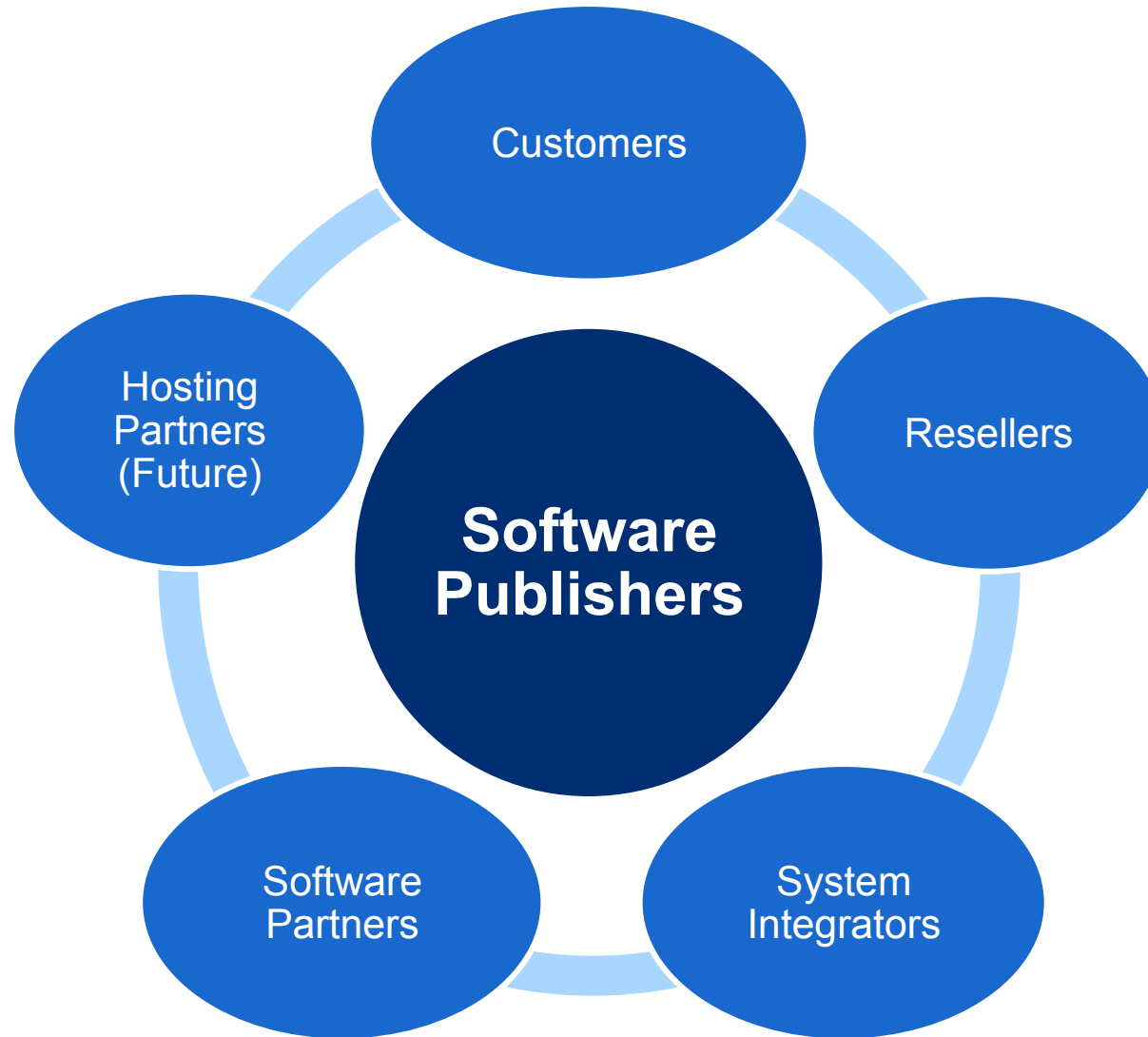

## ELMT Coordination Spectrum

### IT Asset Managers (ITAMS) and Originating Organizations POCs

- Support daily contract mgmt
- Validated and coordinate Center/Program requirements
- POC for Center funding

### Resource Analyst

- Coordinate with funding organization
- Manage funding process
- Collect and track funding

### Value Added Resellers and Original Equipment Manufacturers

- Respond to NASA requirements
- Provide the software delivery mechanism
- Coordinate all communication with the NASA community with the ELMT
- Align company practices with Federal Law, the FAR, NASA SEWP and/or GSA Schedule

### Office of Procurement

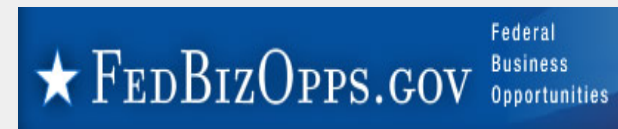
- Responsible for Procurement Policy
- Provide guidance and approval of acquisition approaches that are subject to the "Master Buy Plan" requirements (NFS 1807.71)

### Associate CIO for Enterprise Services and Integration (OCIO)

- Provide guidance of appropriate notifications to IT Boards (e.g., ECAB, EASB, ITMB)
- Approve/fund base services and mods
- Support reconciliation for base services

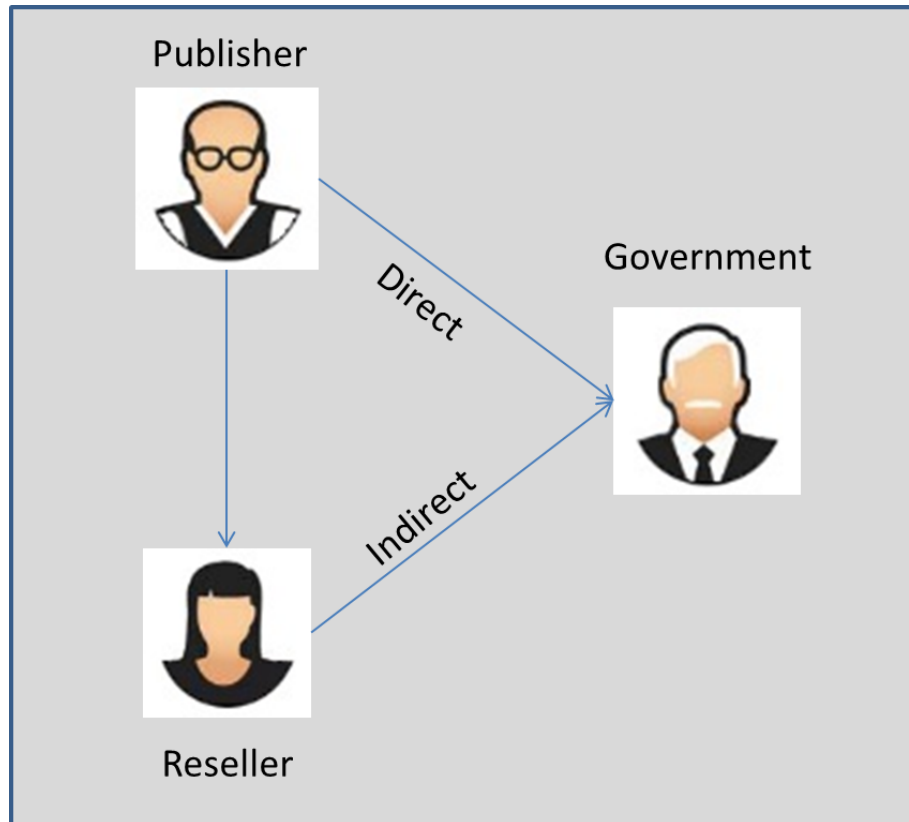
### Enterprise License Mgmt Team (ELMT)

With whom is the Government entering a contract?

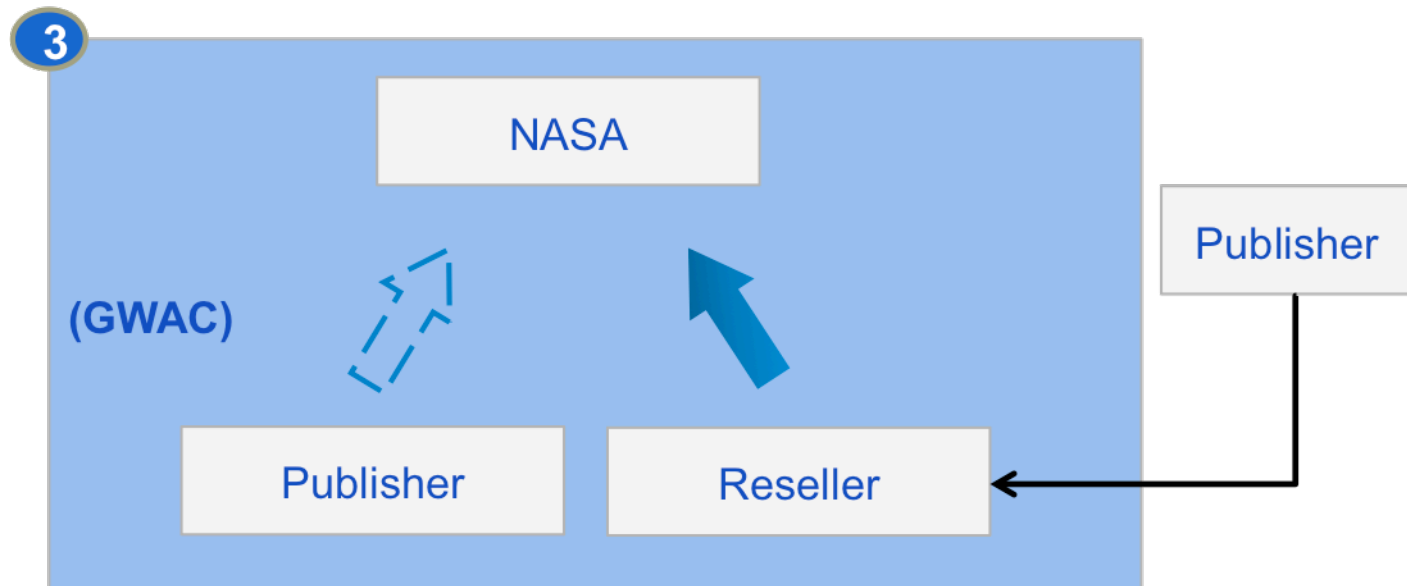
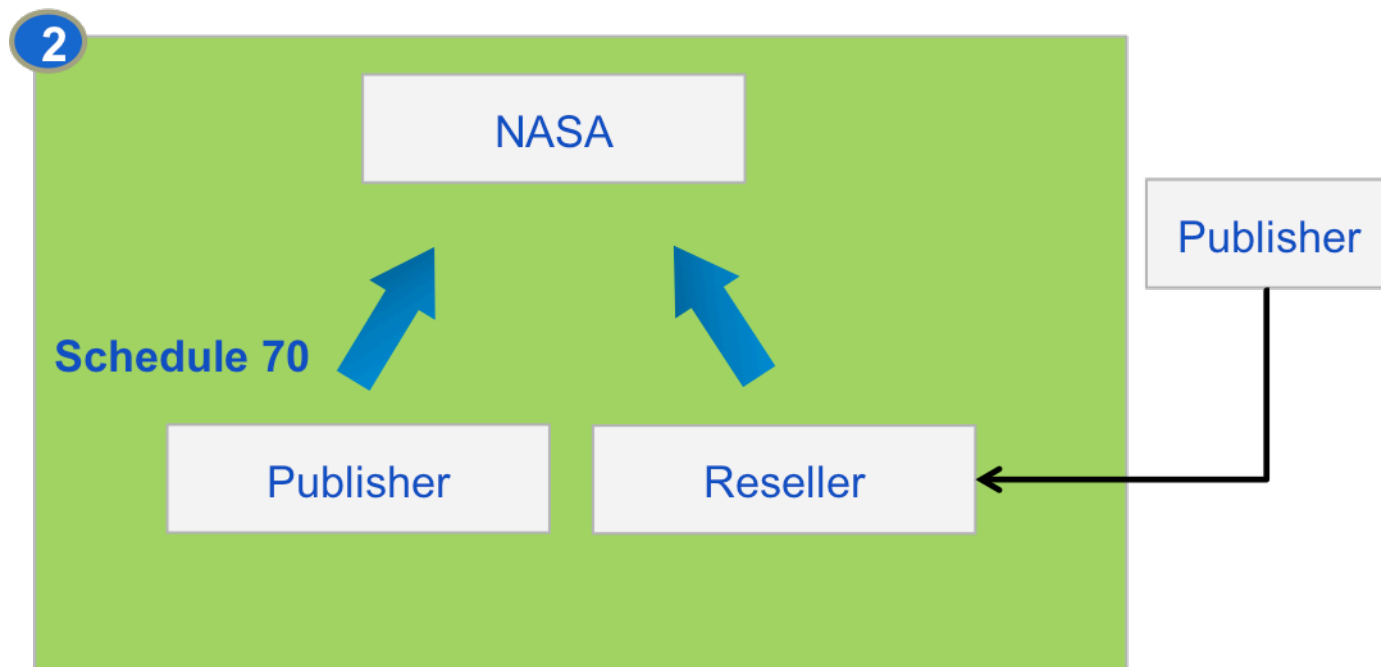


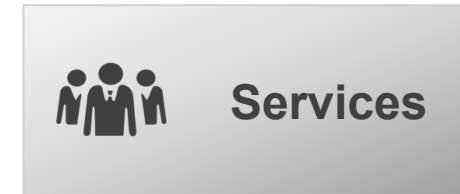
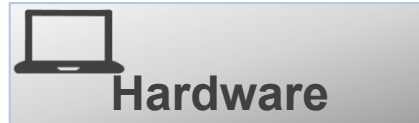
## Privity of Contract (*defined*)

1. A relationship between two parties that is recognized by law.
2. A connection or bond between parties to a particular transaction.
3. The relationship that exists between two or more parties to an agreement.

Contract law requires "privity of contract" between parties to enable either of them to enforce contract promises against the other party.

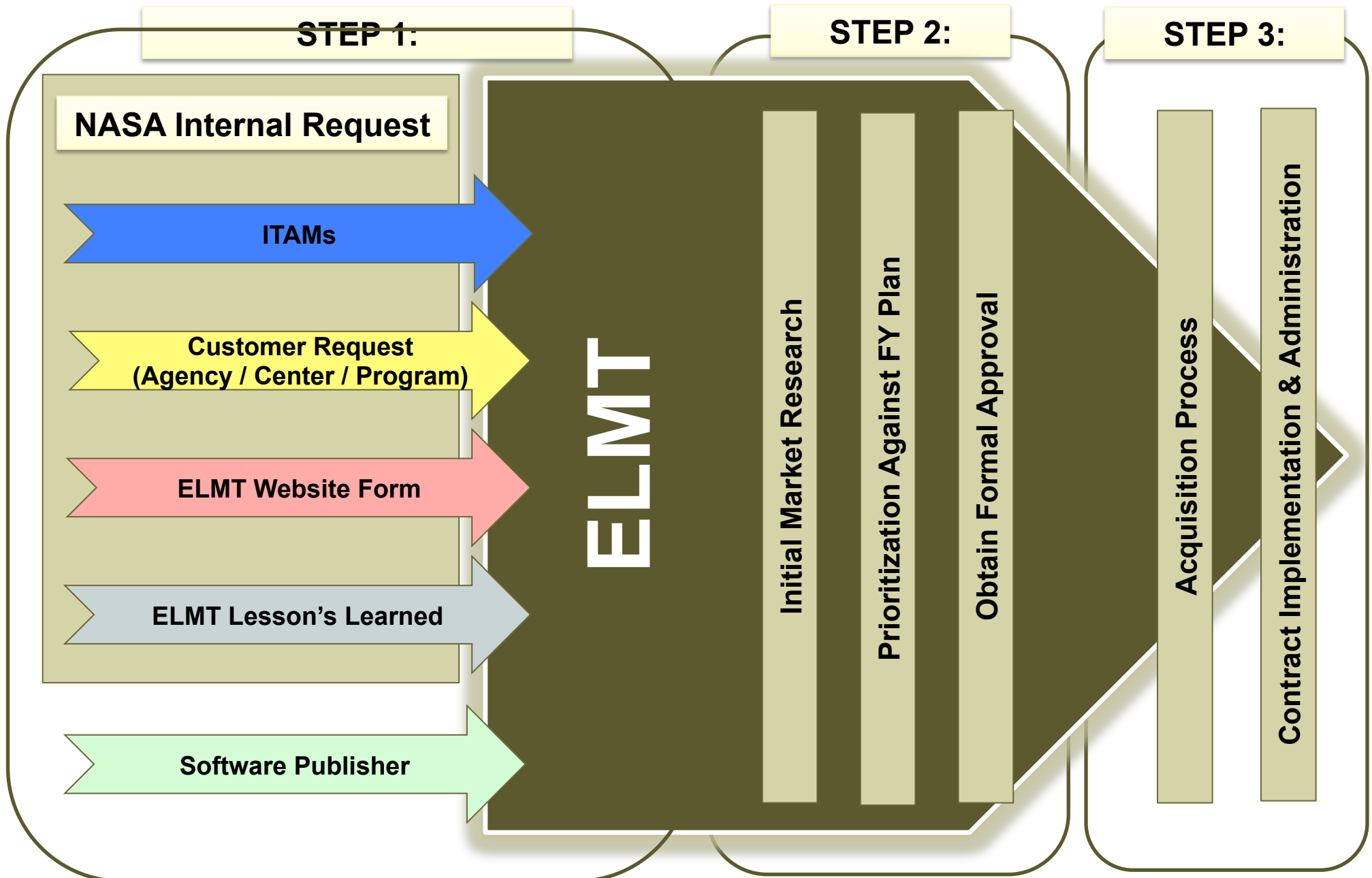
